**1. ADOPTION OF THE AGENDA OF THE 53<sup>rd</sup> MEETING**

It was moved by Councillor Compton Hobbs and seconded by Councillor Crann to adopt the agenda of the 53<sup>rd</sup> meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried.

**2. DELEGATIONS**

- a. Jamie Abbass addressed Council on behalf of concerned residents on Lyall Street and surrounding streets with respect to a letter that was distributed by the Town Engineer to selected residents in the area. The letter speaks to the extension of Kelland Drive and the Town's proposal to construct a berm with a six feet high privacy/sound barrier fence. Mr. Abbass said he spoke to several residents that would be directly affected, as well as other residents in the general area. He said 36 people were concerned with the short notice to provide feedback. He said he hopes this is only the planning stages and urged Council to give further thoughts to a public consultation so residents can provide feedback and ask questions.

**12. Council Forum**

Deputy Mayor Pomeroy spoke of the radio interview with Stan Marshall announcing that Muskrat Falls is all but completed. He said Council lobbied for a plan to re-vitalize the community after Muskrat Falls, but the Provincial Government did not come through to help the community adapt. He said the community is left to pick up the pieces with homelessness, addictions, mental health issues and deteriorated infrastructure; with no additional funding. He said Gull Island is downstream and wonders will the Town be ready for that.

Councillor Crann said the new year has brought much loss and he offered his condolences to all that have lost loved ones. He said Saturday, March 7<sup>th</sup> is the Salvation Army Community meal and encouraged anyone that would like to volunteer to come out and help.

Youth Councillor Ryan said she is looking forward to the Winter Carnival and is working to recruit students to help out with Family Fun Day. She expressed her excitement that the outdoor rink is being completed and looks forward to using it.

Councillor Compton Hobbs said preparations for the Winter Carnival are moving along and she is looking forward to Glow Night on the outdoor rink. She said she attended the Combined Councils of Labrador AGM and it was very informative. She said she and the Mayor had a brief discussion with the Premier about Muskrat Falls. She said there was discussion about homelessness and the need to keep this in the forefront. Councillor Compton Hobbs spoke of the Annual Pancake Breakfast today and that it raised \$6112.00 for the Homelessness initiative. Councillor Compton Hobbs spoke of the RV Park and said she would like to be included in the meetings with ACOA as she has been an advocate for this project from the start. She requested a copy of the design from the Engineer.

Councillor Baikie offered condolences to those that have lost loved ones. She acknowledged Mr. William Burden's recent passing and the time he served on Council for the betterment of the community. Councillor Baikie said she is looking forward to Winter Carnival and encouraged all to get involved. She said she attended the breakfast today and was pleased with the turnout. Councillor Baikie acknowledged the Arena staff for the extra work that was put in to clean up the water and sewer issues this past weekend.

Mayor Andersen said that he, Councillor Crann and PR Manager Waylon Williams attended the Northern Lights Conference and met with four Ministers during their stay. He said there was discussion about the importance of 5 Wing Goose Bay being the Gateway to the North, and the necessity of Successor Rights in the contract to protect jobs and wages. He said they were accompanied by GBAC at two of the 4 meetings where there was good discussion on what they would like to see the Base look like in ten years. Mayor Andersen said he attended the CCL AGM and it was likely the most beneficial AGM he has seen in five years. He said he brought forward a Resolution regarding Hydro Rates and also had the chance to express these concerns with members of Government. Mayor Andersen said he had the pleasure of attending Mrs. Dorothy Michelin's 100<sup>th</sup> Birthday party followed by a visit to his mom who is 102. Mayor Andersen offered thanks to the arena staff for their quick response and clean up after the Water and sewer misfortune this past weekend. He offered condolences to the family of the Late William Burden, noting Mr. Burden was a pillar of strength in this community. Mayor Andersen said he is arranging a meeting with the Premier and will advise Council once the date has been confirmed.
