- a. To help further protect the health, safety and welfare of all residents of Happy Valley-Goose Bay and other communities within Labrador, in connection with the continuing and evolving threat posed to public health by COVID-19, it is moved that Council support and approve the following:
  - 1. That the Town of Happy Valley-Goose Bay encourage all residents of Upper Lake Melville-which includes Happy Valley-Goose Bay, Mud Lake, North West

River and the Innu First Nation of Sheshatshiu-to not travel to other communities with in or outside Labrador unless it is deemed absolutely essential;

- 2. That the Town of Happy Valley-Goose Bay encourage all persons residing outside of Upper Lake Melville not to visit the area unless it is deemed absolutely essential; and
- 3. That roadside information and public awareness checkpoints be established at entry points in Happy Valley-Goose Bay, namely on the Trans Labrador Highway and at the main gate to 5 Wing Goose Bay, to advise visitors and the public at large of the Town of Happy Valley-Goose Bay's desire to discourage all non-essential travel to and from Upper Lake Melville.

Moved by Deputy Mayor Pomeroy and seconded by Councillor Dyson-Edmunds. Councillors were given the opportunity to voice their opinion on this recommendation. Councillor Baikie voted against the Motion and all others voted in favour of the Motion. Motion carried.
