1. ADOPTION OF THE AGENDA OF THE 58th MEETING

It was moved by Councillor Crann and seconded by Deputy Mayor Pomeroy to adopt the agenda of the 58th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

2. DELEGATIONS-None

3. ADOPTION OF THE MINUTES OF THE 57th MEETING

It was moved by Councillor Crann and seconded by Deputy Mayor Pomeroy to approve the adoption of the minutes of the 57th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

4. CORRESPONDENCE

There were 4 incoming letters in correspondence this month.

Mayor Andersen called for a recess at 5:07 Pm due to some technical issues. The meeting reconvened at 5:08 PM.

5. MUNICIPAL SERVICES- Councillor Shawn Crann

It was moved by Councillor Crann and seconded by Councillor Dyson-Edmunds to accept the Municipal Services committee report for May as presented. All in favour. Motion carried unanimously.

Mayor Andersen called for another recess at 5:13 PM due to technical issues and resumed the meeting via teleconference at 5:22 PM.

Recommendations:

- a. The Municipal Services Committee recommends that Council award a contract to Hickman Motors Limited for the supply of a pickup truck in the amount of \$47,858.40, HST included. Moved by Councillor Crann and seconded by Deputy Mayor Pomeroy. Councillor Dyson-Edmunds voted against the Motion. All others voted in favour. Motion carried.
- b. The Municipal Services Committee recommends that Council award a contract to Goose Bay Motors for the supply of a high roof service van in the amount \$61,789.50, HST included. Moved by Councillor Crann and seconded by Deputy Mayor Pomeroy. Councillor Dyson-Edmunds voted against the Motion. All others voted in favour. Motion carried.

6. COMMUNITY SERVICES AND RECREATION - Councillor Jackie Compton Hobbs.

It was moved by Councillor Compton Hobbs and seconded by Councillor Crann to accept the Community Services and Recreation committee report for May as presented. All in favour. Motion carried unanimously.

Recommendations:

a. Contract Award Husky Park Fencing/Backstop-The CSR committee recommends to Council that a contract for the supply of fencing for Husky Park be awarded to Provincial Fence Products in the amount of \$12,369.72. Moved by Councillor Compton Hobbs and seconded by Councillor Dyson-Edmunds. All in favour. Motion carried unanimously.

b. Trail System Upgrades- The CSR committee recommends that a Prime Consultant Agreement be finalized with DMG Consulting Limited to proceed with design, tender document preparation and contract administration at a cost of \$79,534.00 subject to the approval by the Department of Municipal Affairs and Environment. Moved by Councillor Compton Hobbs and seconded by Councillor Dyson-Edmunds. All in favour. Motion carried unanimously.

7. **DEVELOPMENT AND PLANNING- Deputy Mayor Bert Pomeroy**

It was moved by Deputy Mayor Pomeroy and seconded by Councillor Dyson-Edmunds to accept the Development and Planning committee report for May as presented. All in favour. Motion carried unanimously.

Recommendations:

- a. Crown Land Application 129554 Groves Point-The DP committee recommends that Council; Have no objection for the Crown Lands application 129554 for the Crown Land application with the following conditions: Compliance with all the Town's Development Regulations. Moved by Deputy Mayor Pomeroy and seconded by Councillor Dyson-Edmunds. All in favour. Motion carried unanimously.
 - Deputy Mayor Pomeroy deemed a possible conflict with the next recommendation and excused himself from the meeting for Council to decide if he was indeed in conflict. At 5:46 PM Council voted unanimously that he would be in conflict and proceeded to carry on with the recommendation.
- b. Crown Land Application 156635-22 Strathcona Street- The DP committee recommends that Council have no objection for the Crown Lands application 156635 with the following conditions: Compliance with all the Town's Development Regulations. Moved by Councillor Dyson-Edmunds and seconded by Councillor Compton Hobbs. All in favour. Motion carried unanimously.
 - Deputy Mayor Pomeroy returned to the meeting at 5:49 PM.
- c. DLU Lay Down Area-29 Aspen Road-The DP committee recommends that Council approve the Discretionary Land Use Application related to Crown Grant #156048 with the following conditions: Compliance with all the Town's Development Regulations, 1.8M Fence be erected around the limits of the property, include a

letter of approval from NL Hydro for fence on easement, conformance to comments received by other Crown Land referral agencies and that the storage of unregistered and uninsured vehicle of any type not be permitted. Moved by Deputy Mayor Pomeroy and seconded by Councillor Dyson-Edmunds. All in favour. Motion carried unanimously.

8. ECONOMIC DEVELOPMENT AND PUBLIC ENGAGEMENT- Councillor Lori Dyson-Edmunds

It was moved by Councillor Dyson-Edmunds and seconded by Councillor Crann to accept the Economic Development and Public Engagement committee report for May as presented. All in favour. Motion carried.

9. Enforcement and Emergency Services- Councillor Joe Tremblett

In Councillor Tremblett's absence, it was moved by Councillor Compton Hobbs and seconded by Councillor Dyson-Edmunds to accept the Enforcement and Emergency Services committee report for May as presented. All in favour. Motion carried.

Recommendations:

a. Off Road Utility Vehicle-The EES committee recommends that the Town allocate funds to purchase an Off-Road Utility Vehicle to a maximum amount of \$22,000.00 plus HST. Moved by Councillor Compton Hobbs and seconded by Councillor Dyson-Edmunds. Councillor Compton Hobbs and Councillor Dyson-Edmunds voted in favour of the motion. Councillor Baikie, Councillor Crann, Deputy Mayor Pomeroy and Mayor Andersen voted against the motion. Motion was defeated.

10. FINANCE, ADMINISTRATION AND POLICY- Councillor Michelle Baikie

It was moved by Councillor Baikie and seconded by Councillor Crann to accept the Finance, Administration and Policy committee report for May as presented. All in favour. Motion carried unanimously.

Recommendations:

a. Application for Property Tax Relief-The FAP Committee recommends that Council deny the application for property tax relief for Par ID 079884 as it does not meet the requirements of Policy F0009. Moved by Councillor Baikie and seconded by Councillor Crann. Councillor Compton Hobbs voted against the motion and all others voted in favour of the motion. Motion carried.

b. Water Shut Offs-The FAP committee recommends that Council proceed with water shut off to the following properties: Parcel ID's 201257, 212616, 212623, 079715, and 078999 due to non payment of taxes. Moved by Councillor Baikie and seconded by Deputy Mayor Pomeroy. All in favour. Motion carried unanimously.

12. **Council Forum**
