**Topic: TAXI REGULATIONS IMPLEMENTATION**

**Policy Statement:**

Council has adopted new Taxi Regulations and there are steps required in implementing these Regulations.

- 1) Council approves the following employees be appointed as “Inspectors” for the purposes of the Taxi Regulations of the Town of Happy Valley-Goose Bay;
  - Director of Protective Services
  - Chief Administrative Officer, or Designate
- 2) Council approves that the issuance of taxi driver’s licenses and issuance of the taxi operator’s licenses under the Taxi Regulations of the Town of Happy Valley-Goose Bay be delegated to the Inspectors.
- 3) The Inspector under the Town’s Taxi Regulations will conduct one inspection of a vehicle under application for a taxi operator’s license for the purposes under the Regulations of the review of; meter location and visibility, posting of fares, interior appearance, and exterior appearance. The Inspector may conduct subsequent inspections should deficiencies be noted in the original inspection.



**Topic: TAXI REGULATIONS IMPLEMENTATION CONTINUED**

**Policy Statement:**

- 4) By Council policy, a “fit and proper person” to hold a taxi driver’s license in accordance with Section 7 of the Town’s Taxi Regulations will be determined by a Vulnerable Sector Check required under 8 (c) and a Driver’s Abstract under 8(e) of the Town’s Taxi Regulations. An Inspector appointed under the Town’s Taxi Regulations may consider a clear Vulnerable Sector Check and driver’s abstract as “a fit and proper person” under Section 7 of the Regulations. A person without a clear Vulnerable Sector Check would not be issued a taxi drivers license. The Inspector may use discretion should the driver’s abstract indicate incident(s) that are of limited fault of the driver, or minor in nature.
