

MONTHLY POLICING REPORT February 2023 Happy Valley-Goose Bay RCMP Detachment "B" Division

TO: Mayor and Council, Town of Happy Valley-Goose Bay, Newfoundland and Labrador.

The Happy Valley-Goose Bay RCMP Detachment responded to a total of 375 occurrences, which were classified as calls for service during February 2023, compared to 385 occurrences in 2022.

A total of 90 persons were incarcerated for a variety of Offences during the month of February

Annual Performance Plan (A.P.P.'S) Community Priorities

- (1) Enhance Road Safety Improve Road Safety Through Education and Enforcement;
- (2) Crime Reduction Reduce Crimes against Persons/Property;
- (3) Community Relations Build and Maintain Positive Relations with our Community

The 2022/2023 Happy Valley Goose Bay RCMP Annual Performance Plan has been set with final updates on assigned priorities and goals which help us focus on the above noted areas. The progress of this plan will be monitored throughout the year.

(1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement Goals have been set for improved Traffic initiatives, with increased traffic enforcement and regular checkstops to help combat Impaired Driving. Members continue to seek opportunities to conduct strategic checkpoints and partner with Traffic Services to combat Impaired Drivers and HTA Offences. Members will also be looking to conduct ATV Patrols during the summer and Skidoo Patrols during the Winter. During the month of February HVGB RCMP held two Skidoo Operators Courses to provide training to local members to increase the Detachments ability to conduct these patrols.

Crime Reduction – Reduce Crimes against Persons/Property

Goals have been set for proactive initiatives to help reduce crimes against persons and property. Detachment members will undertake to implement additional measures to monitor persons bound by court orders to ensure compliance. Regular compliance checks are conducted on persons bound by Court Imposed Conditions to ensure compliance and charges are pursued when persons are found in breach of those conditions.

(2) Community Relations – Build and Maintain Positive Relations with our Community

Detachment Commander will ensure there is regular contact and communication with Mayor and Council to ensure any issues are brought forward and plans made to address any identified issues. Detachment Commander will also ensure regular contact is maintained and meetings planned with partner agencies to seek opportunities to work together and help resolve any arising issues. Detachment members continue to try and increase contact with the local youth with regular contact/visits made to local schools. School Liaisons have been appointed to maintain contact with Local Schools

****The APP is the main objective, outside of responding to calls for service, of the Detachment and helps direct members efforts each and every day.****

Notable Investigations:

2023147616 – Assault by Choking – On Feb 1st HVGB RCMP responded to a report of a disturbance at a residence where it was reported that a 25 Year old male was assaulting his spouse. Members attended and arrested the 25 Year Old male for Assault by Choking along with several counts of breaching a court order. The male was held and brought before the court.

2023156861 – Break and Enter – On Feb $3^{\rm rd}$, HVGB RCMP responded to a report of a Break and Enter at a residence. Upon investigation Members arrested a 28 year old male who was subsequently charged with Break and Enter, Theft Under \$5000, Breach of Probation, and Breach of a Court Order. The male was held in custody and brought before the court.

2023163102 – Impaired Operation – On Feb 5th HVGB RCMP conducted a vehicle stop and during roadside screening arrested a 19 year old male for Impaired Operation. The male provide breath samples above the legal limit and has been charged with Impaired Operations of a Motor Vehicle.

2023227742 – Assault Causing Bodily Harm – On Feb 18th HVGB RCMP responded to a report of an assault. Upon investigation members learned that a female had been assaulted and transported to the hospital for medical treatment. Member arrested and charged a 33 year old male for Assault Causing Bodily Harm and held to be brought before the court

2023235239 – Counterfeit Currency – On Feb 20th HVGB RCMP responded to a report that a counterfeit bill had been passed at a local business. Members attended and seized the bill. Members distributed a media release and numerous tips were received to help Identify a suspect in this matter. Investigation is ongoing

2023253704 – Fail to Comply – On Feb 24th HVGB RCMP received information that a male who is bound by court ordered conditions related to charges of Sexual Assault and Sexual Interference was in breach of those conditions by having contact with the Victim of the assaults, being in contact with persons under the age of 16, and in breach of an Interim Order Prohibiting Contact. Members attended the residence and arrested the 31 year old male. The male was charged, held in custody, and brought before the courts.

2023269695 – Assault Causing/Assault with Weapon – On Feb 28th HVGB RCMP responded to a report that a male was in possession of a weapon and assaulted family members. Members attended the scene and were able to arrest a 25 Year old male in relation to this incident. The male was charged with Assault With a Weapon, Assault Causing Bodily Harm, Uttering Threats(X3), Forcible Confinement, Mischief Under \$5000, and Breaching a Court Order. The male was held in custody and brought before the court. The male remains in custody and will appear in court at a later date.

2023273573 – Impaired Operation – On Feb 28th HVGB RCMP conducted a vehicle stop and during roadside screening arrested a 24 year old male for Impaired Operation. The male provide breath samples above the legal limit and has been charged with Impaired Operations of a Motor Vehicle.
