The Happy Valley-Goose Bay RCMP Detachment responded to a total of 593 occurrences, which were classified as calls for service during December 2024, compared to 521 occurrences in 2023.

A total of 167 persons were incarcerated for a variety of Offences during the month of December

**Annual Performance Plan (A.P.P.'S) Community Priorities**

- (1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement;**
- (2) Crime Reduction – Reduce Crimes against Persons/Property;**
- (3) Community Relations – Build and Maintain Positive Relations with our Community**

The 2023/2024 Happy Valley Goose Bay RCMP Annual Performance Plan has been set with final updates on assigned priorities and goals which help us focus on the above noted areas. The progress of this plan will be monitored throughout the year.

**(1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement**

Goals have been set for improved Traffic initiatives, with increased traffic enforcement and regular checkstops to help combat Impaired Driving. Members will seek opportunities to conduct strategic checkpoints and partner with Traffic Services to combat Impaired Drivers and HTA Offences. Members will also be looking to conduct ATV Patrols during the summer and Skidoo Patrols during the Winter.

**(2) Crime Reduction – Reduce Crimes against Persons/Property**

Goals have been set for proactive initiatives to help reduce crimes against persons and property. Detachment members will undertake to implement additional measures to monitor persons bound by court orders to ensure compliance. Regular compliance checks are conducted on persons bound by Court Imposed Conditions to ensure compliance and charges are pursued when persons are found in breach of those conditions.

**(3) Community Relations – Build and Maintain Positive Relations with our Community**

Detachment Commander will ensure there is regular contact and communication with Mayor and Council to ensure any issues are brought forward and plans made to address any identified issues. Members will also seek to further engage with the Community through partnerships and engagement in Community Events. Detachment members continue to try and increase contact with the local youth with regular contact/visits made to local schools. School Liaisons have been appointed to maintain contact with Local Schools.

HVGB RCMP Officers helped organize and arrange the arrival and distribution of a large supply of Toys and Hockey Equipment to coastal communities as part of the Toys for the North Program. Toys and equipment was received and distributed throughout the Coastal Communities

**Notable Investigations:**

20241763204 – Theft of Motor Vehicle – On Dec 3<sup>rd</sup> HVGB RCMP responded to a report of a stolen vehicle. With the assistance of the HVGB Municipal Enforcement Officer, Members were able to locate the stolen vehicle and arrested two persons for possession of stolen property. Upon further investigation one of the individuals was released without charges, but a 23 year old female was charged with Possession of Stolen Property and will appear in court at a later date

20241775327 – Aeronautics Act – On Dec 5<sup>th</sup> HVGB RCMP responded to report of a Disturbance on an Air Borealis Flight. Members attended and arrested a 33 year old female for assaulting another passenger who had to be restrained by the Co-Pilot and passengers. Mary Lou Harris was held for court and has been charged with Assault, Mischief, and charges under the Aeronautics Act. She returns to court later in January.

20241785384 – Assault Police Officer – On Dec 7<sup>th</sup> HVGB RCMP responded to a disturbance and located a 27 year old female who had an outstanding warrant of arrest. The female was arrested and during the interaction with police, she spit on and assaulted the officer. The female was held for court on the outstanding warrant and was also charged with Assaulting the Police Officer.

20241789536 – Assault Policer Officer – On Dec 8<sup>th</sup> HVGB RCMP responded to a report of an intoxicated male causing a disturbance at a residence. Members attended and arrested a 53 year old male. During the interaction with Police the male resisted arrested, assaulted the officer, Uttered Threats while being bound by Court Ordered conditions. The male was subsequently charged with Resist Arrest, Assaulting a Police Officer, Uttering Threats, and Breaching a Court Order. The male was brought before the court.

20241808183 – Assault with a Weapon – On Dec 12<sup>th</sup> HVGB RCMP responded to a report of a possible stabbing. Members attended and arrested a 31 year old male for Assault with a Weapon and Breaching a court order. A female was transported to the hospital for medical treatment of non life threatening injuries.

20241808766 – Assault Police Officer – On Dec 12<sup>th</sup> HVGB RCMP responded to a report of an intoxicated male passed out along the road. Members attended and arrested a 32 year old male. During the arrest, the male resisted and assaulted the officers. He was subsequently charged with Resist Arrest and Assaulting a Police Officer.

20241840713 – Assault Causing Bodily Harm – On Dec 19<sup>th</sup> HVGB RCMP responded to a report of an assault. Upon attending members arrested a 30 year old male for Assault Causing Bodily Harm and breaches of a Court Order. The male was held in custody and brought before the court where he was released on conditions to appear at a later date

20241861194 – Assault Police – On Dec 24<sup>th</sup> HVGB RCMP responded to a report of an intoxicated male causing a disturbance. Members attended and arrested a 27 year old male who resisted and assaulted the responding officers. The male was subsequently charged with Resist Arrest and Assaulting a Police Officer.
