Annual Performance Plan (A.P.P.'S) Community Priorities

- (1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement;**
- (2) Crime Reduction – Reduce Crimes against Persons/Property;**
- (3) Community Relations – Build and Maintain Positive Relations with our Community**

The 2023/2024 Happy Valley Goose Bay RCMP Annual Performance Plan has been set with final updates on assigned priorities and goals which help us focus on the above noted areas. The progress of this plan will be monitored throughout the year.

(1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement

Goals have been set for improved Traffic initiatives, with increased traffic enforcement and regular checkstops to help combat Impaired Driving. Members will seek opportunities to conduct strategic checkpoints and partner with Traffic Services to combat Impaired Drivers and HTA Offences. Detachment Members conducted several Skidoo patrols in the area conducting enforcement and offering education on applicable legislation.

(2) Crime Reduction – Reduce Crimes against Persons/Property

Goals have been set for proactive initiatives to help reduce crimes against persons and property. Detachment members will undertake to implement additional measures to monitor persons bound by court orders to ensure compliance. Regular compliance checks are conducted on persons bound by Court Imposed Conditions to ensure compliance and charges are pursued when persons are found in breach of those conditions.

(3) Community Relations – Build and Maintain Positive Relations with our Community

Detachment Commander will ensure there is regular contact and communication with Mayor and Council to ensure any issues are brought forward and plans made to address any identified issues. Members will also seek to further engage with the Community through partnerships and engagement in Community Events. Detachment members continue to try and increase contact with the local youth with regular contact/visits made to local schools. School Liaisons have been appointed to maintain contact with Local Schools.

******The APP is the main objective, outside of responding to calls for service, of the Detachment and helps direct members efforts each and every day.******

Notable Investigations:

2025270091 – Impaired Operation – On March 1st HVGB RCMP responded to a report of a vehicle off the road. Upon attending began an Impaired Operation investigation and the 44 year old male driver failed roadside testing. The Male was arrested for impaired operation and provided samples above the legal limit. The male is facing charges of Impaired Operation and Driving over 80mg, along with Highway Traffic Act Offences. The male was issued a driving suspension and the vehicle was impounded.

2025270690 – Assault Police Officer – On March 1st HVGB RCMP responded to a report that a male was causing a disturbance. Members attended and observed an agitated male. The male was

arrested and during the arrest, the 27 year old male assaulted the responding officers. The male is facing charges of Assault Police Officer(X2), Resist Arrest, and Mischief.

2025274306 – Assault Causing Bodily Harm – On March 2nd HVGB RCMP responded to a report that a female had ran to a neighbours residence seeking help. Members attended and learned that the female had been assaulted by her partner and required medical attention. Members arrested a 42 year old male on scene for Assault Causing Bodily Harm, Assault(Choking), Resist Arrest, and Breach of a Court order. The male was held and brought before the court. The female was transported to the Hospital where she was treated for her injuries.

2025283397 – Assault – On March 4th HVGB RCMP responded to a report of a disturbance at a residence. Upon attending members learned that a female had caused damage in the home, assaulted two people in the home, one of which was a youth, and was in breach of multiple court ordered conditions. A 31 year old female was arrested and charged with Mischief, Assault(X2), and multiple breaches of imposed conditions. Female was held in custody and brought before the court.

2025296745 – Resist Arrest – On March 6th HVGB RCMP responded to a report of three persons causing a disturbance at a local business. Members attended and two of the parties were cooperative and departed on their own. A 28 year old female refused to cooperate and was arrested. During the arrest the female remained uncooperative and aggressive with members and is facing charges of resist arrest.

2025300821 – Possession – On March 7th HVGB RCMP responded to a report of a female causing a disturbance at a residence. Members attended and arrested a 41 year old female. During the arrest and search, members located a quantity of cocaine in the females possession. The female is facing charges of Possession of Cocaine

2025324161 – Uttering Threats – On March 12th HVGB RCMP responded to a report of a disturbance at a residence. Upon attending members were advised that the male indicated that he had a weapon and threatened to kill Police. Members were able to arrest a 34 year old male who is facing charges of Uttering Threats to Kill Police, Resist Arrest, Mischief, Public Mischief, and breach of a court order

2025325759 – Public Mischief – On March 12th HVGB RCMP received a report that a male had been assaulted by a female. The male provided a statement indicating that he was assaulted. During the investigation it was learned that the incident was captured by video surveillance. Upon review of the surveillance footage it was learned that the male had lied during his statement. A 23 year old male has been charged with Public Mischief related to this matter

2025349534 – Sexual Assault/Drug Trafficking – On March 17th HVGB RCMP responded to a report of a female in distress in a roadway. Members attended and during the course of the investigation grounds existed for charges of sexual assault against a 44 year old male. HVGB RCMP, along with Lab District GIS, and Police Dog Services executed a Search Warrant at a residence. The 44 year old male was taken into custody, along with several other occupants. As a

result of the search a quantity of drugs, drug paraphernalia, weapons and cash were seized. The 44 year old male was brought before the court to face charges of Sexual Assault, Possession for Purpose of Trafficking Cocaine, and Possession of property obtained by Crime. The investigation is ongoing and further charges are possible.

2025359722 – Assault Police Officer – On March 19th HVGB RCMP responded to a report of an intoxicated male in the roadway. Members attended and located the male and upon placing him under arrest, the male assaulted the responding officers. The male was taken into custody and is facing charges of Assaulting a Police Officer(X3) and Resist arrest

2025359821 – Assault – On March 19th HVGB RCMP responded to a report of an assault. During the investigation a Search Warrant was executed at a residence and a 49 year old male was arrested and charged with Assault and Breach of a Court Order and a 54 year old male was arrested and is facing charges of Unsafe storage of a firearm, Unauthorized possession of a Firearm, and Possession of a Firearm knowing possession is unauthorized.

2025364275 – Assaulting a Police Officer – On March 20th HVGB RCMP responded to a report that a male had threatened a family member and was enroute to hurt them. Members were able to locate the male and placed him under arrest. The male was found in possession of a weapon and began to assault officers. The 26 year old male was taken into custody and continued to assault and resist officers. The male is facing charges of Uttering Threats, Mischief, Assault Police Officer(X2), Possession of a weapon for a Dangerous Purpose, Resist Arrest, and fail to comply with a court order.

2025367208 – Resist Arrest – On March 21st on HVGB RCMP responded to a report of an intoxicated male passed out on the trail. Upon attending the officers located the male who was aggressive with members. The 23 year old male is facing charges of Resist arrest, Mischief, and Breach of Probation

2025404473 – Possession – On March 28th HVGB RCMP located a vehicle off the road way while on patrol. Member entered into an Impaired Driving Investigation. The male was arrested for Breaching a court order and was found in possession of a controlled substance. The male was arrested and held to be brought before the court for Breaching a Court Order, Possession of a controlled substance, and for Highway Traffic Act offences. The impaired operation remains under investigation.
