**TO:** Mayor and Council, Town of Happy Valley-Goose Bay, Newfoundland and Labrador.

The Happy Valley-Goose Bay RCMP Detachment responded to a total of 642 occurrences, which were classified as calls for service during July 2025, compared to 740 occurrences in 2024.

A total of 167 persons were incarcerated for a variety of Offences during the month of July

## Annual Performance Plan (A.P.P.'S) Community Priorities

- (1) Enhance Road Safety Improve Road Safety Through Education and Enforcement;
- (2) Crime Reduction Reduce Crimes against Persons/Property;
- (3) Community Relations Build and Maintain Positive Relations with our Community

The 2025/2026 Happy Valley Goose Bay RCMP Annual Performance Plan is currently under development. The APP assigns priorities and goals which help us focus on concerns raised by Detachment Management, Divisional Priorities, and concerns raised by local Stakeholders. The progress of this plan will be monitored throughout the year. The previous years assigned priorities are noted below.

(1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement Goals have been set for improved Traffic initiatives, with increased traffic enforcement and regular checkstops to help combat Impaired Driving. Members will seek opportunities to conduct strategic checkpoints and partner with Traffic Services to combat Impaired Drivers and HTA Offences.

### (2) Crime Reduction – Reduce Crimes against Persons/Property

Goals have been set for proactive initiatives to help reduce crimes against persons and property. Detachment members will undertake to implement additional measures to monitor persons bound by court orders to ensure compliance. Regular compliance checks are conducted on persons bound by Court Imposed Conditions to ensure compliance and charges are pursued when persons are found in breach of those conditions.

# (3) Community Relations – Build and Maintain Positive Relations with our Community

Detachment Commander will ensure there is regular contact and communication with Mayor and Council to ensure any issues are brought forward and plans made to address any identified issues. Members will also seek to further engage with the Community through partnerships and engagement in Community Events. Detachment members continue to try and increase contact with the local youth with regular contact/visits made to local schools. School Liaisons have been appointed to maintain contact with Local Schools.

\*\*\*\*The APP is the main objective, outside of responding to calls for service, of the Detachment and helps direct members efforts each and every day.\*\*\*\*

### **Notable Investigations:**

2025929100 – Sexual Assault – On July 1<sup>st</sup> HVGB RCMP received a report that a male suspect had inappropriately touched a female youth at a community event. Upon investigation a 41 year old male was arrested and charged with Sexual Assault and will appear in court at a later date

2025944116 – Armed Robbery – On July 4<sup>th</sup> HVGB RCMP responded to a report of an Armed Robbery at a local business. Labrador District General Investigation Section took over lead on this matter which resulted in the search of a 37 year old male suspect. The 37 year old male was later arrested and charged with Robbery, Assault with a Weapon, Pointing a Firearm(X2), Resist Arrest, Flight from Police, B&E, and several other offences. A 45 year old male was also

arrested and charged related to the subsequent investigation and is facing charges of Flight from Police, B&E, and Fail to Attend Court

2025946621 – Assault with a Weapon – On July 4<sup>th</sup> HVGB RCMP received a report that a male had been assaulted. Upon attending it was learned that a male suspect armed with a weapon attempted to assault another male while uttering threats. It was learned this was the second such occurrence involving the same victim and suspect. A 45 year old male was arrested and charged with a Uttering Threats, Assault with a Weapon(X2), Assault Causing Bodily Harm, and Fail to Comply with a Court Order(X2). The male suspect has been remanded into custody

2025972846 – Assault – On July 8<sup>th</sup> HVGB RCMP received a report that an Inmate at Labrador Correctional Center had been assaulted by another inmate. Incident reports and video footage was obtained from LCC and a 37 year old male has been charged with Assault

2025972303 – Pointing a Firearm – On July 8<sup>th</sup> HVGB RCMP were advised that that a male suspect had pointed a firearm at male youth. A 37 year old male was arrested and charged with Pointing a Firearm and brought before the courts. This matter was related to several other ongoing matters involving the 37 year old male

2025982699 – Dangerous Operation of a Motor Vehicle – On July 10<sup>th</sup> while HVGB RCMP members were on patrol, members noted a Dirtbike driving dangerously on the roadway. The vehicle was weaving between vehicles and driving at excessive speeds. RCMP Air Services was patrolling the area and noted the suspect vehicle. RCMP Air Services was able to direct responding members to the location where the 33 year old male suspect was arrested for Dangerous Operation and the Dirtbike was seized

20251001001 – Impaired Operation – On July 13<sup>th</sup> HVGB RCMP received a report of a possible impaired driver. Members were able to locate the suspect vehicle and conduct a traffic stop. A 28 year old was arrested for Impaired Operation and provided breath samples above the legal limit. The male is facing charges of Impaired Operation, Driving Over 80mg, and Obstruction. The driver was also issued a driving suspension and the vehicle was impounded.

20251012127 – Theft – On July 15<sup>th</sup> HVGB RCMP received a report that a male had entered a store and fled with items without paying. Members were able to locate and arrest a 48 year old male who is now facing charges of Theft, Fail to Comply with a Court Order, and Resist Arrest

20251011547 – Threats – On July 15<sup>th</sup> HVGB RCMP arrested a 36 year old male related to a Causing a Disturbance complaint and lodged the male in cells. While in cells the male began to threaten the guard on duty and was subsequently arrested and charged with Uttering Threats and brought before the Court

20251041716 – Assault with a Weapon – On July 20<sup>th</sup> HVGB RCMP responded to a report of an assault. Members learned that a female had been assaulted by another female who was in possession of a weapon. Members were able to locate and a 28 year old female who has been charged with Assault, Assault with a Weapon, Uttering Threats, and Forcible Confinement.

20251067754 – Flight from Police – On July 25<sup>th</sup> Lab District GIS member attempted to conduct a traffic stop, but the driver, known to Police, fled from Police. Patrols of the area were conducted by GIS, HVGB Detachment members, and Police Dog Service and the involved vehicle was located abandoned. The vehicle has been seized and impounded. Sheshatshiu RCMP was able to locate the 23 year old suspect. The male was arrested and charged with Flight from Police, Dangerous Operation, Fail to Comply with Court Order, Resist Arrest, and Possession of Cocaine. The male has since been remanded into Custody

20251099624 – Impaired Operation – On July 30<sup>th</sup> HVGB RCMP received a report of a possible impaired driver. Members were able to locate the suspect vehicle and conduct a traffic stop. A 21 year old male failed roadside testing and was arrested for Impaired Operation. The male driver provided breath samples which were twice the legal limit. The male is facing charges of Impaired Operation and Driving Over 80mg. The driver was also issued a driving suspension and the vehicle was impounded.
