**1. ADOPTION OF THE AGENDA OF THE 32<sup>nd</sup> MEETING**

It was moved by Councillor Broomfield and seconded by Councillor Winters to adopt the agenda of the 32<sup>nd</sup> meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

**2. DELEGATIONS**

Councillor Pomeroy declared conflict as his employer runs the Homeless Shelter and left Council Chambers at 5:08 PM. Councillor Compton Hobbs also declared conflict as she is the chair of the Housing Coalition and left Council Chambers at 5:09 PM.

- a) Elaine Hinks-Ms. Hinks addressed Council on behalf of approximately 900 citizens of HV-GB that have signed a petition against building a low barrier homeless shelter in HV-GB. She said that a treatment centre is necessary to give those with addictions a safe and peaceful place to become clean and sober, however a low barrier Homeless Shelter is not that.

Councillor Pomeroy and Councillor Compton Hobbs returned to Council Chambers at 5:13 PM.

- b) Stephanie Normore-Ms. Normore spoke to Council with respect to when the MEO position will be filled. She also questioned if the Town has a safety plan in place for spring/summer 2023 stating that as a citizen and business manager this community cannot handle another year like last year. Mayor Andrews advised that Council will be meeting this week with respect to filling the MEO position.
