# 5. COMMUNITY PLANNING & DEVELOPMENT-Councillor Hayward Broomfield

It was moved by Councillor Broomfield to approve the Community Planning and Development Committee report for April. Seconded by Councillor Winters. All in favour. Motion carried unanimously.

Mayor Andrews asked that the minutes of the April 18<sup>th</sup> meeting of the CPD Committee be amended to record he was present as ex-officio. Councillor Compton Hobbs also asked Engineer Randy Dillon if Kelland Drive Ground Water Study is still scheduled for June. Dillon confirmed it was. He also advised that the groundwater is lower given the weather and precipitation we had this winter. Councillor Broomfield asked Dillon if Council will meet when the report has been received. Dillon advised this is correct.

Recommendations: none.

## 6. COMMUNITY SERVICES AND RECREATION-Deputy Mayor Ella Wallace

It was moved by Deputy Mayor Wallace to approve the Community Services and Recreation Committee report for April. Seconded by Councillor Rumbolt. All in favour. Motion carried unanimously.

Recommendations:

a. Policy A0020 - "Community Recognition"

Councillor Pomeroy requested an overview of the Policy. Deputy Mayor Wallace explained the policy has not been revised since 2013 and it is not facilitated anymore. Council does volunteer week in place of the banquet outlined in the policy.

## Motion #2023-04-01

The CSR Committee recommends Council rescind Policy A0020 "Community Recognition". Moved by Deputy Mayor Wallace and seconded by Councillor Broomfield. All in favour. Motion carried unanimously.

# 7. FINANCE, ADMINISTRATION & POLICY- Councillor Denise Rumbolt

It was moved by Councillor Rumbolt to approve the Finance, Administration and Policy Committee report for April. Seconded by Councillor Winters. All in favour. Motion carried unanimously.

Councillor Rumbolt advised that Committee has to deal with each case individually and the first recommendation has three parts to it. Councillor Rumbolt stated Committee thought a donation for SPCA was the best fit. Councillor Compton Hobbs asked what year SPCA was asking for a tax exemption for. Councillor Rumbolt confirmed it was the 2023 tax year. Councillor Compton Hobbs explained this was hard for her to read as the SPCA did a plea recently stating they may need to close their doors. Mayor Andrews reiterated that this was a three-part recommendation. Councillor Compton Hobbs expressed the Council should exempt from property and business tax as well as provide a donation, in her opinion. Councillor Pomeroy asked why the Town would charge \$2,400, and donate \$2,500, as it seems as though we are working backwards. Deputy Mayor Wallace explained when it comes to tax exemptions for not-for-profit (NFP) organizations it has to be across the board that the Council is denying requests. Deputy Mayor Wallace confirmed with Chief Administrative Officer (CAO), Nadine MacAulay that Council could not bill a business at a 0% mil rate. MacAulay confirmed this was correct. Mayor Andrews advised the Committee talked about coming together for a policy for NFPs and it was turned down. The denial and donation net out to zero. Council has denied some groups, and this is an attempt to contribute to the SPCA's financial hardship. Councillor Winters explained Council used to give \$2,500 as a donation to the SPCA, so this donation will offset their property tax. Councillor Pomeroy advised the last couple meetings there has been confusion with denying

recommendations and if the applicant needed to re-apply. Mayor Andrews explained this is why the Committee wanted to recommend a donation. Councillor Pomeroy expressed he wants to switch the recommendation so it is less confusing. Mayor Andrews explained that would be a hostile change to a recommendation and therefore it should remain as is. He said Council has turned other entities down, so from the Committee's perspective, they need to work on the sixteen businesses that fall in this category. Councillor Rumbolt shared that the Director of Financial Operations explained how the budget process works in terms of property and business tax and revenue coming in. When an entity is exempt it ruins the budget. This is the rationale behind the donation. Councillor Broomfield stated the Council is increasing the donation expense by \$2,500. Revenue is staying the same, but we are increasing our expenses. Councillor Compton Hobbs shared the SPCA is asking for a total exemption of \$3,200 and we are giving them a donation of \$2,500. She would exempt both. Deputy Mayor Wallace thought we could not exempt the whole thing. CAO MacAulay advised the Council could exempt the whole thing if they chose to, the Town just has to bill at a mil rate and then exempt if they choose to do so.

## a. Motion #2023-04-02

SPCA Property Tax Exemption Request-The FAP Committee recommends Council deny an exemption for property tax for the SPCA in the amount of \$2,404.60 on PAR ID 260300. Moved by Councillor Rumbolt and seconded by Councillor Winters. Mayor Andrews, Deputy Mayor Wallace, Councillor Broomfield, Councillor Rumbolt, and Councillor Winters voted in favour of the motion. Councillor Compton Hobbs and Councillor Pomeroy voted against. Motion carried.

## b. Motion #2023-04-03

SPCA Business Tax Exemption Request-The FAP Committee recommends Council deny an exemption for business tax for the SPCA in the amount of \$874.40 on PAR ID 260300002 due to the reduction of the mil rate for Not-for-Profit at the March 2023 Public Council meeting. Moved by Councillor Rumbolt and seconded by Councillor Winters. Mayor Andrews, Deputy Mayor Wallace, Councillor Broomfield, Councillor Rumbolt, and Councillor Winters voted in favour of the motion. Councillor Compton Hobbs and Councillor Pomeroy voted against. Motion carried.

## c. Motion #2023-04-04

SPCA Cash Donation-The FAP committee recommends Council approve a cash donation to the HV-GB SPCA in the amount of \$2,500.00. Moved by Councillor Rumbolt and seconded by Deputy Mayor Wallace. All in favour. Motion carried unanimously.

# **d.** Donation Request- Melville Public Library

Councillor Pomeroy asked if this was once a grant to the Library. The CAO MacAulay stated the last six years it has come out of the donation budget. Mayor Andrews expressed he asked this question at the Committee meeting and maybe they could look into this for future. Councillor Pomeroy asked if we receive financial reports from these organizations every year. CAO MacAulay confirmed we receive financials from the Library but not SPCA. Councillor Compton Hobbs wanted to note that there is a typing error in the recommendation, the % should be a \$.

#### Motion #2023-04-05

Donation Request-Melville Public Library- The FAP committee recommends Council approve a donation in the amount of \$5,000 to the Melville Public Library for the fiscal year 2023. Moved by Councillor Rumbolt and seconded by Councillor Winters. All in favour. Motion carried unanimously.

## e. Interest Relief-Lloyd Hillier

Councillor Compton Hobbs asked for background on the letter that was sent from the applicant. Mayor Andrews asked CAO MacAulay if we were able to disclose. CAO MacAulay asked Councillor Compton Hobbs what further information she required. Mayor Andrews disclosed there are privacy issues with this request. CAO MacAulay explained the applicant is asking for interest relief.

## Motion #2023-04-06

Interest Relief Request-Lloyd Hillier-The FAP Committee recommends Council deny the request for interest exemption of \$3,428.00 on PAR ID 262453. Moved by Councillor Rumbolt, Seconded by Councillor Winters. All in favour. Motion carried unanimously.

# f. Interest Relief-Lloyd Hillier

Councillor Pomeroy asked if these were two separate properties as the exemption amount was the same in this request and the previous. CAO MacAulay confirmed two separate parcel IDs are listed in each recommendation.

## Motion #2023-04-07

Interest Relief Request-Lloyd Hillier-The FAP Committee recommends Council deny the request for interest exemption of \$3,428.00 on PAR ID 079971. Moved by Councillor Rumbolt, Seconded by Councillor Pomeroy. All in favour. Motion carried unanimously.

# g. Water & Sewer Tax Relief Request-Lloyd Hillier

Mayor Andrews questioned why there is a recommendation to defer. Councillor Compton Hobbs questioned why the Committee did not know the address of the request. Councillor Rumbolt explained the Committee needed further information from the applicant regarding the request.

#### Motion #2023-04-08

Water & Sewer Tax Relief Request-Lloyd Hillier-The FAP Committee recommends Council defer this request until clarification of address is confirmed. Moved by Councillor Rumbolt, seconded by Councillor Winters. All in favour. Motion carried unanimously.

## 8. MUNICIPAL SERVICES- Councillor Todd Winters

Councillor Winters asked Engineer Dillon about the swimming pool closure at the YMCA. Engineer Dillon advised it will start this weekend and should only run for two weeks. That is the intent right now. Councillor Compton Hobbs asked if spring cleanup was discussed at the meeting. Councillor Winters answered they had not. Councillor Compton Hobbs asked if a date was set for spring cleanup or for tree bush cutting. Councillor Winters stated neither was discussed. Councillor Compton Hobbs requested this be added to next meeting's agenda.

It was moved by Councillor Winters to approve the Municipal Services Committee report for April. Seconded by Deputy Mayor Wallace. All in favour. Motion carried unanimously.

## 9. PROTECTIVE SERVICES- Councillor Bert Pomeroy
