The 37th meeting of the 13th Elected Town Council of the Town of Happy Valley-Goose Bay was 1 held on Tuesday, May 23, 2023, at 5:00 PM and called to order by Mayor George Andrews at 5:00 pm.

1. ADOPTION OF THE AGENDA OF THE 37th MEETING

It was moved by Councillor Pomeroy and seconded by Councillor Broomfield to adopt the agenda of the 37th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

2. DELEGATIONS

a. Curtis Saunders-Mr. Saunders spoke to Council as a citizen of HV-GB with several topics. Mr. Saunders expressed his interest in the Town's 5 year plan. He said he attended two of the public sessions and spoke of development happening in areas where there is bog land and suggested more engineering be put in place before allowing further development. He also suggested that during winter months, street corners be widened for easier view of oncoming traffic. Mr. Saunders moved on to the topic of public safety and how he and many other residents are very concerned about the well being and safety of the community. He spoke of the constant issue of people being intoxicated walking the streets or hanging out at local business's. He said people are tired of having to deal with this in our community where they just want to make a living and live in peace. He said this is not the community they all grew up in. Mr. Saunders said he has approached several members of Government,

but with no resolve. He said he approached the Action Committee and got no answers. He said calls placed to the RCMP when someone makes a report is at the discretion of the RCMP. He spoke of the money being invested in a homeless shelter and said these people need help with their addictions, not just a shelter. Mr. Saunders said the Town is celebrating it's 50th anniversary this year and this does not look good.

Mayor Andrews advised Mr. Saunders he is well past the 10 minute time slot for delegations. Mayor Andrews suggested the next delegate speak, and Mr. Saunders could continue after she is finished. At 5:18 PM the meeting was paused for a technical issue. Meeting resumed at 5:29 PM.

- b. Rebecca Pike-Ms. Pike addressed Council on behalf of the Community Clean Up group. She thanked the community for their outstanding participation and said they would like to see the clean up continue all summer. She said the group is working to continue with street clean up (Street Sweepers) and also cleaning up the trails (Trail Blazers). The group is hoping to offer more prizes as incentives and more kid incentive initiatives. The group is asking for donations of used, clean barrels that will be painted and placed around Town in high traffic areas for garbage collection. The group will be hosting a trail ride this Saturday that will cover 30 KM of trails, followed by a BBQ. The group has a Facebook page with more details.
- c. Curtis Saunders-Mr. Saunders continued his delegation. He said by all means put up an addiction centre but not at the expense of the residents. He said he feels for Council on how to deal with this and that the Action committee is a joke. Mr. Saunders said the Federal and Provincial Government is discriminating by taking aboriginals away from their homes and feeding their addictions. He said by all means put an addictions centre here, but not at the expense of the residents of HV-GB.
