1. ADOPTION OF THE AGENDA OF THE 38th MEETING

It was moved by Deputy Mayor Wallace and seconded Councillor Pomeroy by to adopt the agenda of the 38th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

2. DELEGATIONS

a. Rick Dawe-Mr. Dawe spoke to Council regarding the poor condition of the sidewalks, trails and shoulders in Town. Mr. Dawe has a scooter for transportation, and said it is not safe to use his scooter because of these conditions. This limits him from being able to access areas that people without mobility issues can freely access. He said this is not a new concern. Repairs are long overdue and he feels the Town has not made it a priority to put money into maintaining our sidewalks, trails and shoulders. Mr. Dawe said he did not choose to be disabled and he just wants to be able to live his life with the same rights as everyone else. He asked that the Town step up and make things right. He also noted that there are still businesses in Town that are not accessible and that this also needs to be addressed.

Moved by Councillor Pomeroy and seconded by Councillor Compton Hobbs. All in favour. Motion carried unanimously.

10. APPROVAL OF CHEQUES

Councillor Broomfield advised he has resigned from the CCL as it has not been operational for quite some time. A friendly amendment was made to remove cheque #26327 from the cheque list and direction given to the CAO to write a letter to the CCL inquiring about

the status of the organization. It was moved by Councillor Rumbolt and seconded by Deputy Mayor Wallace to approve cheques in the amount of \$590,42.36. All in favour. Motion carried unanimously.
