1. ADOPTION OF THE AGENDA OF THE 40th MEETING

a) Motion #2023-07-03

Strategic Plan 2017-2022 Final Report- Be it resolved that the 13th Council accept the 2017-2022 Strategic Plan Final Report and direct staff to post same to the Town's website. Councillor Broomfield acknowledged this is the previous Town Council report. Mayor George Andrews confirmed and stated that this Council is moving forward with it and is aiming between Sept-Oct for it to be available for everyone. Moved by Councillor Rumbolt and seconded by Councill Compton Hobbs. All in favour. Motion carried unanimously.

b) Motion #2023-07-04

ATIPP- Requirement for a Public Head of Body for ATIPP purposes—
The FAP Committee recommends that Council designate the Chief Administrative
Officer as the Head of the Public Body for the purpose of the Access to Information and
Protection of Privacy Act, 2015 as stipulated in section 109. Councillor Compton Hobbs
asked for clarification and a description of the position. CAO Nadine MacAulay
explained the position as the head of the public body, and a second set of eyes. It was
moved by Councilor Rumbolt and Seconded by Deputy Mator Wallace. All in favour.
Motion carried unanimously.

c) Motion #2023-07-05

Donation Request Labrador Grenfell Health Foundation – The FAP Committee recommends that Council approve a monetary donation of \$500.00 to Labrador Grenfell Health Foundation for the sponsorship of one team registration fee for the Golf Tournament held on August 17, 2023. Councilor Rumbolt clarified that all proceeds of the event are for purchase of medical supplies for Happy Valley-Goose Bay's Labrador Grenfell Health. Councilor Broomfield expressed his concerns about Town staff attending this event, and if they do, they should have to take Annual Leave instead of LEIU. Councillor Pomeroy replied and stated that is decision should be left for operations to decide and that it is a great foundation to support. It was moved by Councillor Rumbolt and seconded for Councilor winters. All in favour. Motion carried unanimously.

Monthly Policing Report attached for June. There was no committee meeting this month.

10. APPROVAL OF CHEQUES

There was a discussion about cheque #26444 Pollett Strategy INC. Councillor Broomfield asked for clarification of how this benefits the Town. CAO Nadine MacAulay explained the person's place with the town such as attending meetings and doing other various tasks. Mayor George Andrews then stated his concerns about continuing doing business and writing cheques for people who are not registered businesses with the town. He expressed that this needs to stop, and Councillor Rumbolt agreed stating that the FAP committee will look into creating a policy to stop this. Councilor Pomeroy expressed his opinion that some businesses are sometimes not worth registering if they are not making a lot of money. Deputy Mayor Wallace stated that she feels this is an operational issue. Councilor Compton Hobbs questioned the cheque #26383 Athletica

Sport Systems to get clarification for what this is, Mayor George Andrews thought it was a clothing company, but CAO Nadine MacAulay corrected him stating that the cheque was for new glass panels for the arena. It was moved by Councillor Rumbolt and seconded by Councillor Pomeroy to approve cheques in the amount of \$958,937.18. All in favour. Motion carried unanimously.
