The 6th meeting of the 13th Elected Town Council of the Town of Happy Valley-Goose Bay was held on Tuesday, December 14, 2021 at 5:38 PM and called to order by Mayor George Andrews.

1. ADOPTION OF THE AGENDA OF THE 6th MEETING

2. MOTION TO AMEND THE AGENDA

It was moved by Deputy Mayor Wallace and seconded by Councillor Broomfield to amend the agenda of the 6th meeting of the Town Council of the Town of Happy Valley-Goose Bay with the insertion of information from a Privileged Meeting and additional recommendations. All in favour. Motion carried unanimously.

Mayor Andrews passed the gavel to Deputy Mayor Wallace for the next item. The Mayor, Councillor Bennett and Councillor Winters left Council Chambers at 5:40 PM

In a privileged meeting of Council held on December 5, 2021, Councillor Winters and Mayor Andrews declared a possible conflict of interest regarding the McLean Crescent Playground and subsequently left the meeting. Councillor Bennett who had previously been found in conflict of interest also left the meeting. Deputy Mayor Wallace called for discussion in the matter of Councillor Winters conflict of interest, then a vote. Council

unanimously voted that Councillor Winters did have a conflict of interest.

Deputy Mayor Wallace called for the vote. All in favour. Carried unanimously.

Deputy Mayor Wallace called for discussion in the matter of Mayor Andrews conflict of interest, then a vote. Council unanimously voted that Mayor Andrews was not in conflict with respect to the McLean Crescent Playground. Mayor Andrews, Councillor Bennett and Councillor Winters returned and were advised of the votes.

Deputy Mayor Wallace called for the vote. All in favour. Carried unanimously.

Mayor Andrews, Councillor Bennett and Councillor Winters returned to Council Chambers ta 5:43 PM. Mayor Andrews resumed chairing the Council meeting.

3. DELEGATIONS

a. Lori Dyson-Edmunds-Ms. Dyson-Edmunds addressed Council regarding the proposed playground in the green space on McLean Crescent and Blake Drive. She said that the previous Council unanimously supported a motion on August 10th. She said she spoke to Municipal Affairs with respect to the process for conflict of interest and rescinding motions and she feels that Council is using a delay tactic to prevent the playground from happening. She said the playground committee is a group of community minded people who are not looking for any money, who already have money for playground equipment that needs to be ordered asap. She said this is a no-brainer and this playground should be a reality. She said she requested the number of for and against letters at the November meeting and she is imploring Council to do what is best for the Town and make the right decision.

3. ADOPTION OF THE MINUTES OF THE 5th MEETING

It was moved by Deputy Mayor Wallace and seconded by Councillor Winters to approve the adoption of the minutes of the 5th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

4. CORRESPONDENCE

There were no incoming letters in correspondence this month. Mayor Andrews advised that a letter addressed to Mr. Rick Kennedy at Hydro with respect to the recent power outage thanking crews for their services was sent today.

5. COMMUNITY PLANNING & DEVELOPMENT-Deputy Mayor Ella Wallace

It was moved by Deputy Mayor Wallace to approve the Community Planning and Development Committee report for December. Seconded by Councillor Broomfield. All in favour. Motion carried unanimously.

Mayor Andrews declared a conflict with the next item and left Council Chambers at 5:52 PM. Deputy Mayor Wallace took the gavel. Council voted unanimously that he is in conflict. Council proceeded to vote on the motion for 64 Adams Loop.

Recommendations:

a. 64 Adams Loop- George Andrews-The CPD recommends that Council approve the application from George Andrews for Discretionary Use Home-Based Business with the following conditions: compliance with all the town's development regulations, compliance with all other provincial or federal authorities as required, compliance with special reference to Section 6.0 "Accessory Use" 6.3 "Home Business in a Residential Land Use Class", and that a fire and life safety inspection as per NFPA 101 be satisfactorily completed. Moved by Councillor Broomfield and seconded by Councillor Duffett. All in favour. Motion carried unanimously.

Mayor Andrews returned to Council Chambers at 5:54 PM and continued to Chair the meeting.

b. 158797 Watson Rumbolt – The CPD committee recommends that Council deny the Town of Happy Valley-Goose Bay Application 158797 for the Crown Land application with the following conditions: Intended use is not permitted or discretionary under the Municipal Plan or Development Regulations in the Environmental Protection zone. It is not consistent with the Water Resources Management Division Policies' Policy for Development in Wetlands and Policy for Flood Plain. Moved by Deputy Mayor Wallace and seconded by Councillor Duffett. All in favour. Motion carried unanimously.

- c. **158824 Charlie F Swain** The CPD committee recommends that Council deny the Town of Happy Valley-Goose Bay Application 158824 for the Crown Land application with the following conditions: residential use is not a permitted or discretionary use in the OSPT zone. Moved by Deputy Mayor Wallace and seconded by Councillor Duffett. All in favour. Motion carried unanimously.
- d. 158870 Pearl Jessie Winters The CPD committee recommends that Council; Deny the Town of Happy Valley-Goose Bay Application 158870 for the Crown Land application with the following conditions: residential use is not a permitted or discretionary use in the OSPT zone. Moved by Deputy Mayor Wallace and seconded by Councillor Duffett. All in favour. Motion carried unanimously.
- e. 1 Mealy Mountain Road Lara Morina-The CPD committee recommends that Council approve the application from Lara Morina for Discretionary Use Home-Based Business with the following conditions: compliance with all the town's development regulations, compliance with all other provincial or federal authorities as required, compliance with special reference to Section 6.0 "Accessory Use" 6.3 "Home Business in a Residential Land Use Class" and that a fire and life safety inspection as per NFPA 101 be satisfactorily completed. Moved by Deputy Mayor Wallace and seconded by Councillor Broomfield. All in favour. Motion carried unanimously.
- f. **Application Process**-The CPD committee recommends that to initiate any development, an application must be completed and submitted before any site visit takes place. Moved by Deputy Mayor Wallace and seconded by Councillor Bennett. All in favour. Motion carried unanimously.

6. COMMUNITY SERVICES AND RECREATION - Councillor Todd Winters

It was moved by Councillor Winters to approve the Community Services and Recreation Committee report for December. Seconded by Deputy mayor Wallace. All in favour. Motion carried unanimously.

Councillor Winters and Councillor Bennett left Council Chambers at 6:03 PM.

Mayor Andrews spoke to the proposed McLean Street Playground. He ensured everyone that this is not a dead issue and Council is not trying to stall the playground. He said Council followed through with a consultation and asked for feedback. He said a total of 108 letters were submitted, 80 positive and 28 concerns. He said there was no motion

from the previous Council to proceed with the funding application for \$50,000. He said Council needs time to evaluate and make the right decisions; and to deal with the issues of concern in a judicial manner. He said he is hopeful that Council will be in a position to make an informed decision by the next Council meeting.

7. FINANCE, ADMINISTRATION & POLICY- Councillor Hayward Broomfield

Councillor Broomfield advised that the Finance, Administration and Policy Committee did not meet in December due to Budget preparation; however, there are recommendations to come forward. The next regular meeting will resume in January.

Purpose of loan: Purchase of a 2008 Peterbilt model 340 4-wheel drive loader in the amount of \$79,000, exclusive of HST, for a term of 36 months at a fixed interest rate of 3.21% as per the results of a public tender call. Moved by Councillor Bennett and seconded by Deputy Mayor Wallace. Councillor Broomfield voted against the motion. All others voted in favour. Motion carried.

- b. 2022/2023 Investing in Canada Infrastructure Program-The Municipal Services Committee recommends that Council approve the submission of applications for the following projects in the 2022/2023 Investing in Canada Infrastructure Program:
 - 1. Road Intersection Upgrades (Local Roads) \$800,000
 - 2. Storm Drainage Improvements (Local Roads) \$914,500
 - 3. 2022 Road Resurfacing (Local Roads) \$750,000

Moved by Councillor Bennett and seconded by Councillor Rumbolt. All in favour. Motion carried unanimously.
