The 88th meeting of the 12th Elected Town Council of the Town of Happy Valley-Goose Bay was held on Tuesday, May 25, 2021 at 5:00 PM and called to order by Mayor Wally Andersen.

Mayor Andersen asked that everyone stand for a moment of silence in memory of the Late Joe Tremblett.

1. ADOPTION OF THE AGENDA OF THE 88th MEETING

It was moved by Deputy Mayor Pomeroy and seconded by Councillor Compton Hobbs to adopt the agenda of the 88th meeting of the Town Council of the Town of Happy Valley-Goose Bay. All in favour. Motion carried unanimously.

2. DELEGATIONS

- a. Elizabeth Zarpa-Ms. Zarpa addressed Council regarding a request for Speed Bumps and a Crosswalk with flashing lights for Perrault Place. She submitted a petition signed by the residents at Perrault Place and advised Council that vehicles often speed through Perrault Place like a thoroughfare, and they are concerned about the safety of their residents and more importantly their children that play outside. She said she feels speed bumps and a crosswalk would help create barriers to vehicles speeding through and make a safer environment for all residents. Council asked that Town Engineer and Superintendent of Public Works visit the site and advise Council and Ms. Zarpa of their decision
- b. Michelle Parsons-Ms. Parsons addressed Council as owner of Labrador Upholstery and LU Designs. Ms. Parsons said she was issued a Stop Work Order last Friday and

she has no idea why this has happened. She said she has spoken to the Town's Municipal Technologist several times over the last few months with respect to her business operations and regulations. She said she was led to believe the Town was working with her. She said she thought they were operating within the rules and has been in operation over 5 months with no concerns until now. She said this Stop Work order is stressful on her family and causing hardship as this is her livelihood. She asked the Town council for help to resolve this issue and hopes no one else has to experience what her family has gone through. Council agreed to meet with Ms. Parsons along with the Town Engineer for further discussion and clarification.

c. Darrelle Bennett-Ms. Bennett addressed Council for clarification on Town Regulations for operating a business. She said she brought concerns to the Mayor and Council about what to do when someone is operating a business without licences, permits, Workers Compensation, Fire inspections, etc. and under a homebased business. She said she Council has not given her an answer. She said her concerns are not about competition and in no way personal, but she feels there should be a level playing field for all business operators. She said she tried calling the complaints line for privacy reasons but was told she could not leave a message without leaving her name. She asked who is liable if the Town is knowingly letting someone operate without proper licences, inspections, etc. She said it is unfair to let one operation do business in one way and another operation do business in another way; it's confusing when someone is operating under a homebased business, but they're not a homebased business. She said she is just asking for fairness. Council agreed that they would discuss this further at DPE meeting.

11. COUNCIL FORUM

Deputy Mayor Pomeroy said it has been a busy month. He said the ground water issue has become a priority and he sympathized with those affected. He said Council is

working to find a long term solution. He said the JP Forestry operation is a big concern with heavy trucks coming through Town several times daily and even though Hamilton River Road is a Provincial Highway, and the Town has no say, he still disagrees with this. He said there will be a lot of disruption with road work happening this summer and Council hopes to find a solution that works for all. He said the Urban Chicken Regulations and Urban Bee Regulations require further discussion and Council will be reaching out to owners for their input. He said the Development Regulations are in place for a reason and Council is bound by them. He said the new regulations were passed in February and are now in place.

Councillor Crann offered condolences to the Tremblett family and said it has been a rough four years with a lot of loss. He passed along greetings PR Manager Waylon Williams who has a birthday on Wednesday.

Councillor Dyson-Edmunds said she is looking forward to Spring Clean Up. She thanked DJ Elliott for the good work he is doing in his new role. She said the loss of Joe was hard and she is thinking about the family.

Councillor Compton Hobbs offered condolences to the Tremblett family. She said there are a lot of meeting happening and more to come even though their term is winding down. She said she is happy to see Minor Soccer back on the go, the Ball Leagues getting back on track and recreation resuming. She asked for clarification at the next DPE meeting with respect to the Development Regulations approval with the Province. She said she is looking forward to working with the chicken owners to find a solution.

Councillor Baikie offered condolences to Joe's family and said she will miss his presence and his smile.

Mayor Andersen offered thanks to DJ Elliott and Julia Kelland in their new roles and said he is getting lots of positive comments. He said Joe has been on everyone's mind the last while and it reminds us to take a deep breath and realize how short life can be. He offered condolences to Nellie, their boys, and their grandchildren and said he will be fondly remembered. He said he's been getting good comments on the sand removal around Town and thanked crews for their work. He referred to JP Forestry and said the ideal route would be South Branch Road. He said with respect to the ground water issue; we can't dwell on the past, we need to work on finding a permanent solution, so this doesn't happen again.

There being no further business, a motion to adjourn the meeting was made by Councillor Compton Hobbs and seconded by Councillor Dyson-Edmunds. All in favour. Motion carried unanimously. Meeting adjourned at 7:09 PM.
