**Policy Statement:** 

BE IT RESOLVED:

That the Town Council of the Town of Happy Valley-Goose Bay fully supports the youth of this community and their executives in delivering quality youth programming.

BE IT RESOLVED:

That the Town Council of the Town Happy Valley-Goose Bay is committed to providing quality facilities at minimal cost for youth organizations to deliver their respective programs.

BE IT RESOLVED:

That the Town Council of the Town of Happy Valley-Goose Bay, is committed to working with the executive of youth organizations to generate revenue to offset expenses that the respective organizations incur when delivering quality programming

THEREFORE:

The Town Council of the Town of Happy Valley-Goose Bay enters into an agreement with the Lake Melville Extreme Minor Hockey Association, the Snowflake Skating Club and the Happy Valley-Goose Bay Minor Soccer Association to *Operate the Canteen Concession* at the E.J Broomfield Memorial Arena for the 2014-2015 Ice Season.

#### **TOPIC: CANTEEEN CONCESSION Continued**

### **Policy Statement:**

- In consideration of the current ice times for the respective groups to deliver their program, the canteen concession is split 66 <sup>2/3</sup> % for Minor Hockey and 33 <sup>1/3</sup> % for Snowflake during the Winter Season.
- To determine which group receives what time frame, a coin toss or name draw will be held. The group winning the toss or having their name drawn will select which time their group will be responsible for the operation of the canteen concession. i.e. Snowflake selects first, chooses February 15 April 30. Minor Hockey will operate from October 17 February 14.
- If this arrangement is acceptable and the canteen concessionary operates as per the policy for the operation of the canteen, for the 2014-2015 season, Snowflake will operate from September 1 November 30 and Minor Hockey will operate from December 1 April 30. The times will continue to be alternated from year to year.
- The Minor Soccer Association will operate the canteen concession from May 1 August 31.

**Note:** Any and all activities/events which occur during a group's allotted time of operation will be the responsible of that particular group.

### **Policy Statement:**

Note:

The monthly rental rate for the canteen concession will be \$500.00 plus H.S.T.

- All groups will have to carry Fire Insurance to satisfy the Town's Insurance Policy. A proof of such Insurance will be on file at the Town Office.
- It will be the responsibility of the Director of Community Services and Recreation to ensure that the canteen concession hours of operation are structured and posted.
- This is a 4 year contract, subject to an annual review.
- This contract does not prevent other organization or groups from fundraising in the E.J. Broomfield Memorial Arena
