TOPIC: VOLUNTEER FIREFIGHTERS APPRECIATION

Policy Statement: The purpose of this Policy is to show appreciation to the Town's Volunteer Firefighters.

It is acknowledged that Volunteer Firefighters may receive other benefits provided by other levels of Federal/Provincial Government.

Finally, the Town does provide Volunteer Firefighters with appropriate supplies and equipment such as bunker gear, pagers along with training, etc. which is not subject to this policy.

- 1. The Town will provide a maximum annual stipend of \$1,000.00 per Volunteer Firefighter paid once a year in December.
- 2. The stipend shall be paid out based on a percentage of participation response to an emergency, training, meetings, events, etc., as determined by the Fire Chief.
- 3. The Fire Chief will track participation and provide an Annual Report of attendance to the Town Manager.
- 4. The Town will provide a turkey during the Christmas season for each volunteer firefighter.
- 5. The Town will provide an additional annual stipend to the Officers, prorated on months of service. The breakdown is as follows:

- •Fire Chief \$1000
- •Deputy Fire Chief X 2 \$750 (\$1500)
- •Captain X 2 \$500 (\$1000)
- •Lieutenant X 2 \$250 (\$500)
- •Training Officer \$250
- •Accountability/Safety Officer \$250.
- 6. The Town will provide \$3,000.00 per year towards an annual Volunteer Firefighter's Appreciation Supper for Volunteer Firefighter's and their spouse/guest.
- 7. The Town will clear snow of driveways for Volunteer Firefighter's principal residence as long as within Town boundaries. Snow clearing will be provided based on priority snow clearing services determined by the Department of Road Transport.
- 8. The Town will acquire license plates to identify vehicle or owner as a Volunteer Firefighter.
