## From the Finance Department

### 2021 Tax Bills

Did you know you can pay your taxes online? Use ONLINE BILL PAYMENT option available through RBC, BMO, Scotiabank, TD Bank and Eagle River Credit Union. To get started,

- 1) Search for "HAPPY" in the payee section;
- 2) Add payee; and
- 3) Type your "Municipal Account Number" (add 5 zeroes to make your Account # a maximum of 11 digits required by your bank). Example: 12345600000. To learn more visit the Town website and look under "Tax Bill Payment Options" in "A - Z Services".

### Incorrect NAME & ADDRESS on your tax bill?

### Property Tax Relief

Residential property owners may be eligible for tax relief. Complete the Property Tax Low Income Relief application form and submit to the Town Hall with a copy of the CRA 2019 Notice of Assessment for each person residing at the address. To access the form, visit the "Quick Links" section of our website and select "Permits & Applications".

### Tax Rebate

Seasonal recreational property owners may be eligible for a tax rebate. To access the form, visit the "Quick Links" section of our website and select "Applications".

### Tax Discount

Deadline for 5% Tax Discount on 2021 Tax Bills extended from April 30 to June 30, 2021.

### Interest Waived

Interest Charges on 2021 Tax billings, including water and sewer fees, waived until July 31, 2021.

### Central Labrador YMCA
