

## MONTHLY POLICING REPORT April 2022 Happy Valley-Goose Bay RCMP Detachment "B" Division Newfoundland and Labrador





**TO:** Mayor and Council, Town of Happy Valley-Goose Bay, Newfoundland and Labrador.

The Happy Valley-Goose Bay RCMP Detachment responded to a total of 562 occurrences, which were classified as calls for service during April 2022, compared to 443 occurrences in 2021.

A total of 148 persons were incarcerated for a variety of Offences during the month of April.

## Annual Performance Plan (A.P.P.'S) Community Priorities

## **Under Development**

Happy Valley Goose Bay RCMP are currently in the process of finalizing the 2022/2023 Annual Performance Plan to assign priorities and goals for Detachment members to focus their proactive duties. The progress of this plan will be monitored throughout the year with progress reported on Quarterly. We will seek input from Mayor and Council to help direct these priorities for the coming year.

\*\*\*\*The APP is the main objective, outside of responding to calls for service, of the Detachment and helps direct members efforts each and every day.\*\*\*\*

## **Notable Investigations:**

2022413126 – Fatal MVC – On April 3<sup>rd</sup> HVGB RCMP responded to a single vehicle (Snowmobile) collision with one person injured. Members attended and a 42 year old male was pronounced deceased on the scene. Paramedics and HVGB GSAR assisted in the recovery.

2022439797 – Impaired Operation – On April 8<sup>th</sup> HVGB RCMP conducted a vehicle stop that resulted in a 21 year old male being arrested for Impaired Operation after a failed roadside test(ASD). The male provided breath samples over twice the legal limit and is facing charges of Impaired Operation of a Motor Vehicle.

2022451661 – Assault Causing Bodily Harm – On April 10<sup>th</sup> HVGB RCMP responded to a Disturbance and upon arrival located an injured female who required medical attention. Members arrested a 51 year old male for Assault Causing Bodily Harm. The male was held and brought before the court.

2022451227 – Coroners Act – On April 10<sup>th</sup> HVGB RCMP responded to a report that an International Flight would be making an emergency landing in HVGB. Members attended along with CBSA and Paramedics. A 40 year old male had passed away on board of the flight. Members liaised with the ME's office and Foreign Departments to ensure all required notifications were completed. Death is not deemed suspicious.

2022467594 – Sexual Assault – On April 13<sup>th</sup> HVGB RCMP responded to a report of a disturbance. Upon attending members arrested a 37 year old male for Sexual Assault, Assault, Assault Causing Bodily Harm, Assault(Choking), Uttering Threats, and Forcible Confinement. The male was held in custody and brought before the courts.

2022481051 – Assault with a Weapon – On April 14<sup>th</sup> HVGB RCMP responded to a report of a disturbance at a residence. Upon arrival, members arrested a 39 year old male for Assault with a Weapon and arrested a 31 year old male for Forcible Entry and Break and Enter. Both males are set to appear in court at a later date.

2022506808 – Assault Police Officer – On April 22<sup>nd</sup> HVGB RCMP responded to a disturbance at a local Hotel. Upon arrival a 52 year old male was arrested for Mischief and Breach of a Court Order. During the interaction the male also assaulted the responding Officers and will also face charges of Assaulting a Police Officer, Mischief, and Fail to Comply with Court Order.

2022517708 – Break and Enter – On April 24<sup>th</sup> HVGB RCMP responded to a report of a B&E at a local business. Upon investigation members arrested a 19 year old male who has been charged with Break and Enter, Mischief, Theft, Forcible Entry, and Disguised with Intent. Male will be appearing in court at a later date.

2022531383 – Drug Possession – On April 26<sup>th</sup> HVGB RCMP conducted a vehicle stop that resulted in the arrest of a 28 year old woman on an outstanding arrest warrant for failing to attend court. Once arrested, members located a quantity of drugs in the female's possession and she was subsequently arrested for Possession of CDSA. The female was held and brought before the court to respond to the outstanding warrant and new CDSA charges.

2022533595 – Aggravated Assault – On April 27<sup>th</sup> HVGB RCMP responded to a report of a Stabbing. Upon arrival members located an injured 38 year old male. Male was transported to LGH and medevac'd to St. John's for further medical attention. A 38 Year old female was arrested for Aggravated Assault, Assault with a Weapon, and Possession of a Weapon for a Dangerous Purpose and held to appear in court.

HVGB Detachment and its members continue to deal with and adjust to the new realities of Covid-19 which continues to evolve. With the rollout of the vaccine we, along with everyone, are hoping a return to regular activities for all.
