**Annual Performance Plan (A.P.P.'S) Community Priorities**

- (1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement;**
- (2) Crime Reduction – Reduce Crimes against Persons/Property;**
- (3) Community Relations – Build and Maintain Positive Relations with our Community**

The 2023/2024 Happy Valley Goose Bay RCMP Annual Performance Plan has been set with final updates on assigned priorities and goals which help us focus on the above noted areas. The progress of this plan will be monitored throughout the year.

**(1) Enhance Road Safety – Improve Road Safety Through Education and Enforcement**

Goals have been set for improved Traffic initiatives, with increased traffic enforcement and regular checkstops to help combat Impaired Driving. Members will seek opportunities to conduct strategic checkpoints and partner with Traffic Services to combat Impaired Drivers and HTA Offences. Members will also be looking to conduct ATV Patrols during the summer and Skidoo Patrols during the Winter. HVGB Detachment conducted a Traffic Blitz on May 27<sup>th</sup> which involved numerous checkstops in different locations around HVGB. Members also conducted Targeted Enforcement in locations for offences of Failing to Stop at Stop Signs, Seatbelt Infractions and Distracted Driving related to the use of Cellphones while driving.

**(2) Crime Reduction – Reduce Crimes against Persons/Property**

Goals have been set for proactive initiatives to help reduce crimes against persons and property. Detachment members will undertake to implement additional measures to monitor persons bound by court orders to ensure compliance. Regular compliance checks are conducted on persons bound by Court Imposed Conditions to ensure compliance and charges are pursued when persons are found in breach of those conditions.

**(3) Community Relations – Build and Maintain Positive Relations with our Community**

Detachment Commander will ensure there is regular contact and communication with Mayor and Council to ensure any issues are brought forward and plans made to address any identified issues. Members will also seek to further engage with the Community through partnerships and engagement in Community Events. Detachment members continue to try and increase contact with the local youth with regular contact/visits made to local schools. School Liaisons have been appointed to maintain contact with Local Schools. Detachment members conducted Presentations to groups of Students at a Career Fair.

**Notable Investigations:**

2023599213 – Sexual Assault – On May 4<sup>th</sup> HVGB RCMP responded to a report of an assault. Upon investigation members arrested a 79 year old male for Sexual Assault. The male is scheduled to appear in court at a later date

2023607898 – Breach of Probation – On May 5<sup>th</sup> HVGB RCMP responded to a report of a distraught female on the highway. Upon attending members located a male and female. The male was bound by a Probation Order to have no contact with the female. The 39 year old male was arrested and charged with Breach of Probation.

2023614652 – Break and Enter/Assault – On May 6<sup>th</sup> HVGB RCMP responded to a report that Three females had attended and cabin, forced entry into the cabin, and assaulted one of the occupants. Members arrested four females, aged 53, 38, 40, and 44. The 44 year old Female has been charged with Break and Enter, Assault, and Mischief. The other three females have been charged with Break and Enter. All are set to appear in court at a later date.

2023620487 – Breach of Court Order – On May 7<sup>th</sup> HVGB RCMP were on patrol and located an intoxicated female near the roadway. It was determined that the female was bound by a Court Order to abide by conditions of a Curfew. The female was arrested and charged with breaching a court order.

2023632212 – Breach of Court Order – On May 10<sup>th</sup> HVGB RCMP responded to a report of an unwanted male at a residence. Upon attending members arrested a 20 year old male who was in breach of numerous conditions. The male was charged with breaching a court order and breaching a Probation Order.

2023638549 – Impaired Operation – On May 11<sup>th</sup> HVGB RCMP responded to a report of an impaired driver. Members located the suspect vehicle and arrested the Driver, 35 year old male, for impaired operation. The male provided breath samples over the legal limit and has been charged with Impaired Driving and Driving over 80. The vehicle was impounded and driver issued a suspension. Charges are before the courts

2023664139 – Sexual Assault W/ Weapon – On May 15<sup>th</sup> HVGB RCMP responded to a report of an intoxicated male with a weapon. Members attended and arrested the male. Upon investigation further information was disclosed that supported additional charges. The 29 year old male was charged with Sexual Assault with a Weapon, Two counts of Assault, Uttering Threats, Assault while Choking, and Breach of a Court Order. The male was remanded into custody and will appear in court at a later date.

2023671327 – Sexual Assault – On May 16<sup>th</sup> HVGB RCMP responded to a report of suspicious behaviour of a vehicle. Upon conducting follow up on the vehicle, members located a victim who disclosed a sexual assault. Members arrested a 74 year old male who has been charged with Sexual Assault, Assault, and Forcible Confinement. The matter is before the courts.

2023685598 – Impaired Operation – On May 19<sup>th</sup> HVGB RCMP responded to a report of an impaired driver. Members were able to locate the suspect vehicle and arrested a 55 year old female for impaired operation. The female provided breath samples Four(4) times the legal limit. The female has been charged with Impaired Operation and Driving over 80. The vehicle was impounded and the female was issued a suspension notice. Charges are before the court.

2023704236 – Assault/Forcible Confinement – On May 22<sup>nd</sup> HVGB RCMP responded to a report of a disturbance at a residence. Members attended and arrested a 36 year old female who has been charged with Assault and Forcible Confinement. The female will be appearing in court at a later date
