**TOPIC: CANTEEN CONCESSION**

**Policy Statement:**

The Town Council of the Town of Happy Valley-Goose Bay fully supports the youth of this community and their executives in delivering quality youth programming.

The Town Council of the Town Happy Valley-Goose Bay is committed to providing quality facilities at minimal cost for youth organizations to deliver their respective programs.

The Town Council of the Town of Happy Valley-Goose Bay is committed to working with the executive of youth organizations to generate revenue to offset expenses that the respective organizations incur when delivering quality programming.

- The Minor Hockey Association will operate the canteen concession from September 1 – April 30
- The Minor Soccer Association will operate the canteen concession from May 1 – June 30.

**Note:** Any and all activities/events which occur during a group's allotted time of operation will be the responsibility of that particular group.

**Note:** The monthly rental rate for the canteen concession will be \$600.00 plus H.S.T.



**TOPIC: CANTEEN CONCESSION Continued**

**Policy Statement:**

- All groups will have to carry Fire Insurance to satisfy the Town's Insurance Policy. A proof of such Insurance will be on file at the Town Office.
- All groups must follow the Provincial Guidelines for Safe Food Handling.
- It will be the responsibility of the Director of Community Services and Recreation to ensure that the canteen concession hours of operation are structured and posted.
- This is a 4 year contract, subject to an annual review.
- This contract does not prevent other organization or groups from fundraising in the E.J. Broomfield Memorial Arena
