12. Council Forum

Councillor Baikie offered congratulations to all involved in the Labrador Winter Games and encouraged all to get out and enjoy the events.

Councillor Compton Hobbs noted the dates of the Labrador Winter Games; March 17-23 and said she is looking forward to partaking in the events. Councillor Compton Hobbs acknowledged three local boys that are participating in Judo Competition at the Canada Games; Nolan, Josh and Tyler and wished them good luck. Councillor Compton Hobbs spoke of recent meetings she, Mayor Andersen and PR Waylon Williams attended in Ottawa with several Ministers. She said the meetings went well and she looks forward to moving ahead with these files. She said they were pleased to be invited to attend Minister O'Reagan's announcement regarding funding for housing in NL and as the Chair of the local Housing and Homelessness committee will be looking for a fair share.

Councillor Dyson-Edmunds said she attended the GBAC AGM last night and it went well. She said she has been approached by a local medical professional regarding having a breastfeeding area in the airport, which she will be working on securing. Councillor Dyson-Edmunds gave a shout out to local residents and business's who continue to support fundraising efforts for people in need. She said this community is amazing and offered thanks.
