Calls for Service

Operations

- Body Cameras – Enforcement is working closely with our CAO; the PIA process was completed, awaiting final decision from CAO and Council as to when the camera can be reissued.
- Working with Innu Nation for CSO Training and developing the working relationship further. Awaiting a call back for training dates from Greg and Clarence.

Public Safety

- Calls from individuals for vagrants and intoxicated persons are still prevalent in the community, 400 individuals were encountered the month of may alone.
- Conducting traffic monitoring on Municipal Streets
- CST Baker has taken part of numerous Action team Meetings; the team has taken some suggestions and there is progress being made.
- The transiently homeless population is continuing to grow, Calls are increasing , dealing with individuals consuming large amounts of hand sanitizer. CST Baker has seized multiple units of hand sanitizer, including whole wall units from the hospital.
- Working on end of June early July for the Bike Rodeo.

Property Standards

The new proposed Property & Community Standards Regulations draft has been completed, Still working on finalization. Files have been created on 3 properties and action already has begun.

Training,

CST Baker attended the 2022 Municipal Police Conference in Clarenville .

May 31- CST BAKER re certified 11 Municipal Police Constables for Use of Force, Officer Safety, Baton and OC Spray.

June 1- CST Baker presented an Officer Safety Workshop.

June 2- CST Baker facilitated a Regulation development workshop, Numerous municipalities requested Happy Valley Goose Bays Dog & Cat regs and the Noise and Nuisance Regs.

June 3- CST. Baker facilitated an Officer Positioning Workshop

As well as was the guest speaker for the Q&A session the conference held.

At the 2022 Annual general Meeting, CST Baker was voted in and accepted the position of Vice President & Training Officer for the province.

Happy Valley Goose Bay was awarded the 2023 Municipal Police Conference , Cst Baker was informed that 2023 is set to be the joint conference with the Atlantic Bylaw Association, Every 2 years the joint conference is hosted in Newfoundland and Labrador.
